Background

Ed is a highly experienced lawyer, business owner and mediator with a background of 20 years in civil litigation. He formally retrained as a civil and commercial mediator in 2015 with a supplemental period of training in 2016 as a family mediator.

Specialising in all aspects of civil disputes, particularly inheritance disputes disputes Ed is also experienced in employment, neighbour disputes and family fall outs involving contact and finance as well as commercial disputes including cross border delivery disputes.

Ed also runs workshops for other mediators his most recent being on inheritance disputes in a mediation setting including the division of shares in family companies. In January 2018 he helped judge the National Mediation Competition at the University of Law, London.

Ed Considers that mediation should be the first port of call for anyone in ANY dispute not just those that traditionally "end up" at mediation.

In his role as consultant lawyer Ed regularly directs clients to other mediators knowing that mediation will save his clients time, money and stress.

Ed remains a consultant legal advisor Haworth and Lees Solicitors Ltd where he worked prior to becoming a mediator, where he consults on commercial property conveyancing and provides business related advice for corporations, family companies and partnerships.

He has also work on an extended contract as a Project Manager for Greater Manchester Academic Health and Science Network ensuring delivery of diagnosis tools based on algorithmic analyses of data sets for Care Commissioning Groups and GPs to assist in identifying under treated or unidentified patients at risk of stroke

For 7 years prior to working for Haworth and Lees Ed was a sole partner with his own legal practice handling high value and complex case loads of injury and clinical negligence claims, including negligent delivery of children
